QUICK FACTS

Is this a new tax?

No. It replaces the expiring levy which was voter approved in 2018.

How will this affect my taxes?

The chart shows the estimated combined tax rates of the EP&O levy, tech levy bond, and state school levy. The local levies and bond rate will be approximately \$2.80 per thousand combined with the state school levy of \$2.70 per thousand, for a total of \$5.50 per thousand (2021) and \$5.53 per thousand (2022).

As the chart shows, Tax Rates have been reduced significantly with the new state funding model which now combines property tax for the entire state. This means small communities do not have to pay as much in taxes to finance schools.

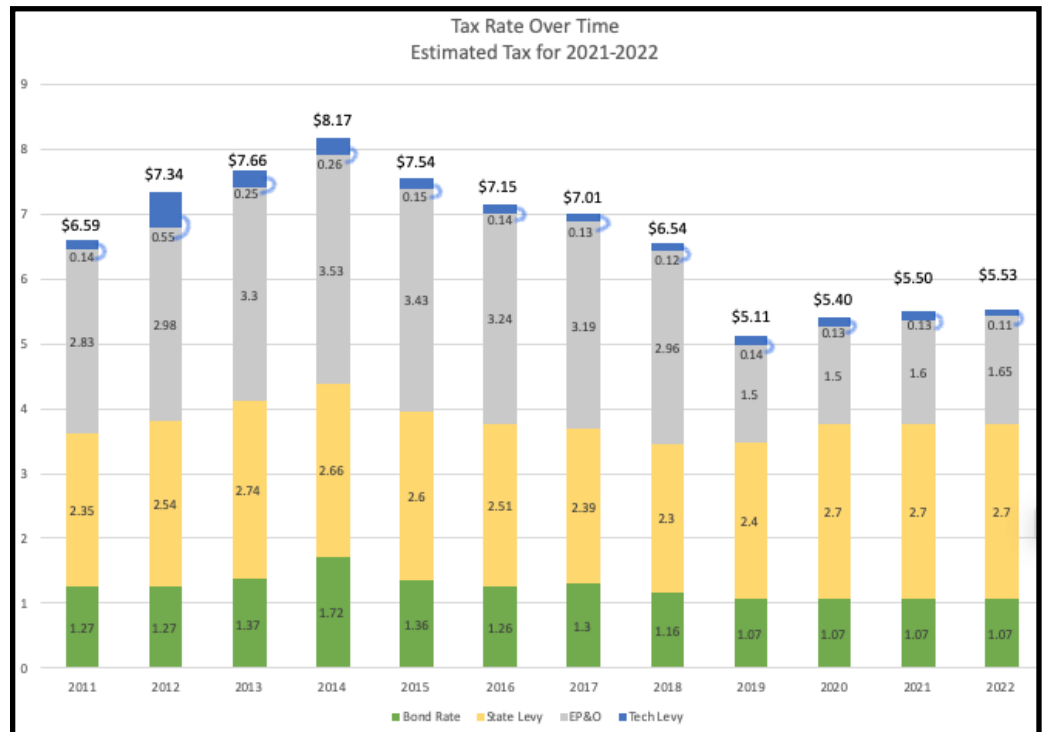
LEVIES ARE FOR LEARNING

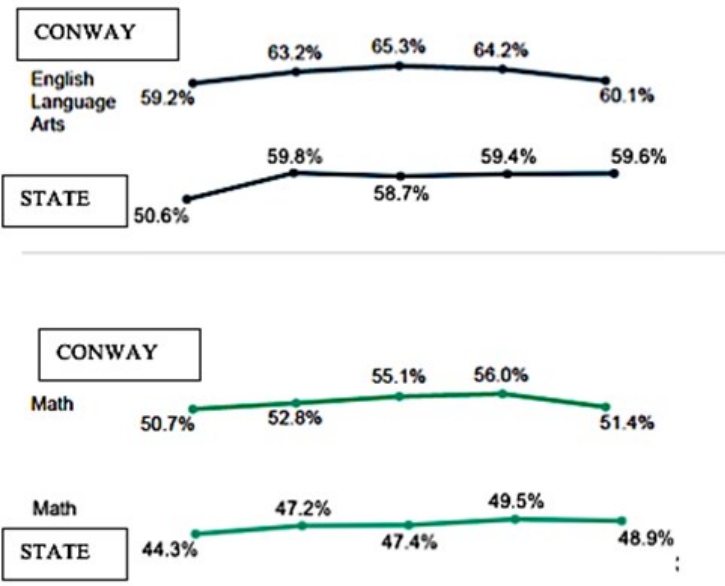
Over the last couple of years, we have adopted both Math and English Language Arts Curriculum. The staff have worked hard to learn the new materials, integrate the state standards, and develop assessments to measure student progress. As with all new curriculum adoptions there is typically an “implementation dip” in assessments that occurs as students and staff get used to the new materials. Once teachers and students become familiar with the new materials, we will see assessment scores start to rise again.

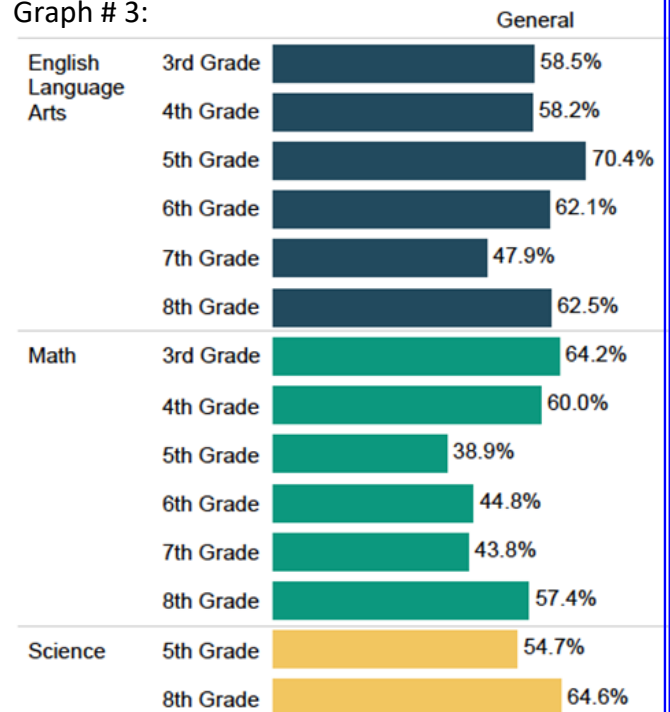
STATE REPORT CARD

Washington State Office of Public Instruction (OSPI) has changed the way data is reported to school districts. Part of the new reporting is combining all grade levels to show growth over time (graphs #1 & 2). While this is one way of showing data, it can distort the results if one grade level had difficulty with the assessment. As you can see by our scores, we have some areas of English Language Arts and Math that need addressing (graph #3). Those areas have been identified in our School Improvement Plan and we are implementing new curriculum as well as focusing our professional development in those areas. We are confident scores will raise over the next couple of years as the teachers and students become familiar with the new curriculum and materials.

*Note: Scores are impacted by students that did not participate in the assessment. For example, in 7th grade data for students who tested is: 51% in Math and 56% in ELA. When the data for non-tested students is added to our total, student pass rates drop by 5-8%.

Message From Principal Dickinson

2019 was a great year for our students academically. On state testing, they performed better than the state average in 11/14 categories for reading, math, and science. Our school improvement goal is to continue to increase student achievement each year by 5%. To accomplish this goal we have adopted a new reading curriculum in kindergarten through second grade as well as sixth through eighth grade. We are also working on ways to improve the support we offer to students needing additional intervention to reach proficiency. Conway's skilled and dedicated staff are helping all students to make progress.

New for our middle school this year are increased class offerings. We were able to accomplish this by changing the schedule to have five class periods that alternate between days. We call this a blue and gold schedule. Students now have the opportunity to take classes like: leadership, Spanish, photography, journalism, recess coach, integrated science, food science, Skagit Valley history, and world history. Students are really enjoying the variety of offerings.

Message From Crystal Kombol, School Counselor

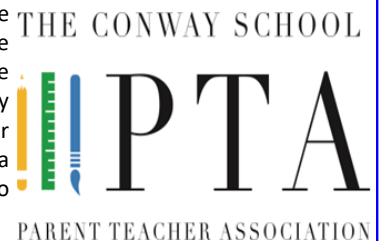
Our school team has been working on expanding our Positive Behavioral Intervention Support (PBIS) framework. As a co-facilitator of our PBIS committee, I work with teachers and students to examine our school-wide systems of teaching, coaching and reinforcing behaviors. We are grateful to have Skagit County Public Health and the U of W's SMART team advise our PBIS program.

In the counseling program, we kicked off the year increasing the number of small groups offered for targeted behavior support from 17 to 23 per week. We continue to offer our Recess Buddies and Brain Builders groups which teach social skills and kindergarten readiness skills. Students in our Zones of Regulation group complete weekly missions to learn skills for self-regulation in the context of team challenges. This year, we added an Anxiety group (Zen Warriors), Cool Cats for anger management and Memory Keepers grief and loss group. All groups are by teacher-parent referral and require consent from parents to participate. We are thankful that Skagit County Public Health continues to staff a part-time school-based therapist to serve youth who may not be able to access behavioral health services and that would benefit from more than our group activities. Our counseling program focuses on Empowering Students and aligning our work with the PBIS framework.
